RESOLUTION GRANTING AUTHORITY TO THE GOVERNOR, HONORABLE ARTHUR D. DEFENSOR, SR., TO ENTER INTO CONTRACT AGREEMENT, FOR AND IN BEHALF OF THE PROVINCE OF ILOILO, WITH *STEVEN CONSTRUCTION AND SUPPLY* FOR THE CONSTRUCTION OF OR/DR COMPLEX AND SURGICAL AND OB WARD, CONSTRUCTION OF COVERED WALKWAY OF DR. FEDERICO ROMAN TIRADOR, SR. MEMORIAL DISTRICT HOSPITAL, JANIUAY, ILOILO, SUBJECT TO ALL THE TERMS AND CONDITIONS STIPULATED THEREIN

"Presented for consideration of the Body under Urgent Measures is the letter dated December 11, 2014 of the Governor, Hon. Arthur D. Defensor, Sr., requesting for authority to enter into contract with *Steven Construction and Supply* for the construction of OR/DR Complex and Surgical and OB Ward, Construction of Covered Walkway of Federico Roman Tirador, Sr. Memorial District Hospital, Janiuay, Iloilo;

WHEREAS, the contract amount of P3,849,980.47 of the said contractor was the Lowest Complying Responsive under Bid No. FRT-14-1397-B as per competitive bidding conducted last October 15, 2014;

WHEREAS, the fund for the said project is chargeable against the 20% IRA (Hospitals and Health Centers);

WHEREAS, the Provincial Legal Office opined that the subject matter is valid pursuant to Section 465 (a) and (b) (1) (vi) (*The Chief Executive: Powers, Duties, Functions and Compensation*) of RA 7160 or the Local Government Code of 1991. Further, the same has gone through a valid public bidding and is justified under Section 16 (*General Welfare*) of the same code;

WHEREAS, in view of the foregoing, it is recommended that the Governor be given authority to sign the said undertaking;

NOW, THEREFORE, on motion of the Honorable June S. Mondejar, Floor Leader, which was duly seconded;






