RESOLUTION APPROVING THE PROPOSED ADDITIONAL DISASTER RISK REDUCTION AND MANAGEMENT PROGRAMS FOR CY 2015 FUNDING IN THE AMOUNT OF P15,492,000.00, CHARGEABLE TO THE PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT FUND-TRUST FUND, PROVINCE OF ILOILO

"Presented for consideration of the Body under Urgent Measures is the 1st Indorsement dated January 14, 2015 of Governor Arthur D. Defensor, Sr., relative to Provincial Disaster Risk Reduction & Management Council (PDRRMC) Resolution No. 2, Series of 2015 re the proposed additional Disaster Risk Reduction and Management Programs for CY 2015 funding thereof be made chargeable to the Provincial Disaster Risk Reduction and Management Fund-Trust Fund of this government;

WHEREAS, Typhoon "Ruby" with maximum sustained winds of 140 kph near the center and gustiness of up to 179 kph affected the entire Province of Iloilo last December 8, 2014 and, as issued by the PAGASA, the entire Province was under Typhoon Cyclone Warning Signal No. 1;

WHEREAS, a lot of needs and programs were observed that require proper response and implementation so as to improve the disaster risk reduction and management programs, response and operation capacities of the Iloilo Provincial Government;

WHEREAS, Section 21 of RA 10121 mandates pre-disaster activities and programs;

WHEREAS, in view of the foregoing considerations, this August Body approves that the proposed additional Disaster Risk Reduction and Management Programs for CY 2015 funding thereof be made chargeable to the Provincial Disaster Risk Reduction and Management Fund-Trust Fund, Province of Iloilo;

NOW, THEREFORE, on motion of the Honorable June S. Mondejar, Floor Leader, which was duly seconded;

RESOLVED, as it is hereby Resolved, to approve that the proposed additional Disaster Risk Reduction and Management Programs for CY 2015 funding in the amount of P15,492,000.00, chargeable to the Provincial Disaster Risk Reduction and Management Fund-Trust Fund, Province of Iloilo listed hereinunder, to wit:







