RESOLUTION RE-PROGRAMING THE PREVIOUSLY APPROVED PROGRAMS AND ACTIVITIES OF THE PDRRMC CONTAINED IN SP RESOLUTION NO. 2014-226 PARTICULARLY ITEM NO. 2 THEREOF, FROM THE FABRICATION OF 600 UNITS OF MOTORIZED FISHING VESSELS WITH ENGINE AND ACCESSORIES @ P20,000.00/UNIT AMOUNT TO P12,000,000.00 TO THE FABRICATION OF 18-20 FEET WOODEN MOTORIZED BOAT IN THE AMOUNT OF P3,990,000.00, AND PROCUREMENT OF ASSORTED KINDS OF FISHING GEARS IN THE AMOUNT OF P8,010,000.00 TOTALING TO THE SAME AMOUNT OF P12,000,000.00 THAT WILL BE DISTRIBUTED TO THE FISHERMEN IN NORTHERN ILOILO WHO WERE AFFECTED BY SUPER TYPHOON "YOLANDA"

"Presented for consideration of the Body under Urgent Measures is the 1st Indorsement dated January 14, 2015 of Governor Arthur D. Defensor, Sr., relative to Provincial Disaster Risk Reduction & Management Council (PDRRMC) Resolution No. 3, Series of 2015 re re-program the previously approved program by the Sangguniang Panlalawigan of Iloilo under Resolution No. 2014-116 on Item No. 2 particularly from the fabrication of 600 units of motorized fishing vessels with engine and accessories @ P20,000.00/unit amount to P12,000,000.00 for the fishermen affected by Super Typhoon "Yolanda" in Northern Iloilo to the procurement of fishing gears for the affected fishermen thereon;

WHEREAS, under Resolution no. 2014-116 the fabrication of 600 units of motorized fishing vessels with engine and accessories @ P20,000.00/unit amounting to P12,000,000.00 for the fishermen affected by Super Typhoon "Yolanda" in Northern Iloilo was among those items approved by this August Body;

WHEREAS, there were a lot of donors who provided financial assistance and finished motorized fishing vessels thereon that the Iloilo Provincial Government through the Office of the Provincial Agriculturist as implementing office held in abeyance on its implementation;

WHEREAS, the need then by the affected fishermen at present are fishing gears for their use;

WHEREAS, in view of the foregoing considerations, this August Body approves the re-programming of the previously approved program by the Sangguniang Panlalawigan of Iloilo under Resolution No. 2014-116 on Item No. 2 particularly from the fabrication of 600 units of motorized fishing vessels with engine and accessories @ P20,000.00/unit amount to P12,000,000.00 to the fabrication of 18-

20 feet wooden motorized boat in the amount of P3,990,000.00, and procurement of assorted kinds of fishing gears in the amount of P8,010,000.00 totaling to the same amount of P12,000,000.00 that will be distributed to the fishermen in Northern Iloilo who were affected by Super Typhoon "Yolanda";

NOW, THEREFORE, on motion of the Honorable June S. Mondejar, Floor Leader, which was duly seconded;






