RESOLUTION RE-ADAPTING THE PREVIOUS APPROVED PROGRAMS AND ACTIVITIES OF THE PDRRMC CONTAINED IN SP RESOLUTION NO. 2014-116, PARTICULARLY ITEMS NO. 3 AND 4 ON PROCUREMENT OF TENTS IN THE AMOUNT OF P400,000.00, AND PROCUREMENT OF UNIFORMS FOR THE MEMBERS OF THE EMERGENCY RESPONDERS OF ILOILO IN THE AMOUNT OF P142,500.00, WITHOUT SPECIFYING THE NUMBERS OF UNITS THEREON

"Presented for consideration of the Body under Urgent Measures is the 1st Indorsement dated January 14, 2015 of Governor Arthur D. Defensor, Sr., relative to Provincial Disaster Risk Reduction & Management Council (PDRRMC) Resolution No. 4, Series of 2015 re the proposal to re-adapt the previously program approved by the Sangguniang Panlalawigan of Iloilo under Resolution No. 2014-116 on Items No. 3 and 4 particularly on procurement of tents, and uniforms for the members of the Emergency Responders of Iloilo;

WHEREAS, under Resolution No. 2014-116, the procurement of tents and uniforms were among those items that were approved by this August Body;

WHEREAS, with the increase of production cost of said items, the procurement of the same was held in abeyance;

WHEREAS, the said items are indeed needs in the risk reduction and management operation of the Provincial Disaster Risk Reduction and Management Office;


