RESOLUTION NO. 2015-053

RESOLUTION AUTHORIZING THE GOVERNOR, HONORABLE ARTHUR D. DEFENSOR, SR., TO SIGN CONTRACT AGREEMENTS, FOR AND IN BEHALF OF THE PROVINCE OF ILOILO, WITH *CHEDMARYL CONSTRUCTION AND SUPPLIES* AND *KJC CONSTRUCTION AND SUPPLY* RELATIVE TO THE HEREINUNDER PROJECTS AND WITH CORRESPONDING AMOUNTS, SUBJECT TO ALL THE TERMS AND CONDITIONS STIPULATED THEREIN

"Presented for consideration of the Body is Committee Report No. 2015-04 of the Committee on Infrastructure, chaired by the Honorable Dennis T. Valencia, relative to the following subject matters, to wit:

1. Letter dated January 8, 2015 of Governor Arthur D. Defensor, Sr., requesting for authority to sign a Contract Agreement with *Chedmaryl Construction and Supplies* to undertake the improvement of Multi-Species Freshwater Hatchery Building at Agri-Aqua Research and Training Center, Nanga, Pototan, Iloilo, of the Provincial Agriculture Office, worth *P551,627.40*;
2. Letter dated January 9, 2015 of Governor Arthur D. Defensor, Sr., asking for authority to sign a Contract Agreement with *Chedmaryl Construction and Supplies* to construct the Repair Bay Building and install the perimeter lightings of the Provincial Equipment Pool, Sta. Barbara, Iloilo, worth *P1,357,215.46*; and
3. Letter of Governor Arthur D. Defensor, Sr., asking for authority to sign the Contract Agreement between the Iloilo Provincial Government and *KJC Construction and Supply* for the construction of Provincial Nursery Concrete Fence (Phase I) at Brgy. Kaingin, Lapaz, Iloilo City in the amount of *Two Hundred Fourteen Thousand Nine Hundred Thirty-two Pesos and 25/100 (P214,932.25)*;

WHEREAS, the improvement of Multi-Species Freshwater Hatchery Building at Agri-Aqua Research and Training Center, Nanga, Pototan, Iloilo of the Provincial Agriculture Office will be undertaken by *Chedmaryl Construction and Supplies* with the lowest calculated responsive bid at a contract price equivalent to Five Hundred Fifty-one Thousand Six Hundred Twenty-seven Pesos and 40/100 (*P551,627.40*). This project has passed through a public bidding under Bid No. AGR-14-1489-B dated October 29, 2014. Moreover, a Notice of Award, dated December 3, 2014 has already been issued in favor of the herein contractor. Funds for this project are chargeable against the Capital Outlay 2014

(Other Structures) as indicated in the copy of Allotment Release Order for Fiscal Year 2014 and Project Procurement Management Plan;

WHEREAS, the construction of Repair Bay Building and installation of perimeter lightings of the Provincial Equipment Pool, Sta. Barbara, Iloilo, will be undertaken by Chedmaryl Construction and Supplies with the lowest calculated responsive bid at a contract price equivalent to One Million Three Hundred Fifty-seven Thousand Two Hundred Fifteen Pesos and 46/100 (P1,357,215.46). This project has passed through a public bidding under Bid No. PEO-14-1377-B dated October 15, 2014. Moreover, a Notice of Award, dated November 21, 2014 has already been issued in favor of the herein contractor. Funds for this project are chargeable against the Capital Outlay 2014 (Other Structures);

WHEREAS, the construction of Provincial Nursery Concrete Fence (Phase I) at Brgy. Kaingin, Lapaz, Iloilo City, will be undertaken by KJC Construction and Supply with the lowest calculated responsive bid at a contract price equivalent to Two Hundred Fourteen Thousand Nine Hundred Thirty-two Pesos and 25/100 (P214,932.25). This project has passed through a public bidding under Bid No. AGR-14-1279-B dated October 15, 2014. Moreover, a Notice of Award, dated December 3, 2014 has already been issued in favor of the herein contractor. Funds for this project are chargeable against the Capital Outlay 2014 (Other Structures) as indicated in the copy of Allotment Release Order for Fiscal Year 2014 and Local Budget Matrix FY 2014;

WHEREAS, the Provincial Legal Office opined that the said contract agreements are valid pursuant to Section 16 (*General Welfare*) in relation to Section 465 (a) and (b) (1) (vi) (*The Chief Executive: Powers, Duties, Functions, and Compensation*) of RA 7160 or the Local Government Code of 1991;

WHEREAS, in view of the foregoing consideration, it is recommended that the Governor be given authority to sign the abovementioned contract agreements;

NOW, THEREFORE, on motion of the Honorable June S. Mondejar, Floor Leader, together with the Honorable Dennis T. Valencia, Chairperson, Committee on Infrastructure, which was duly seconded;



Chua, Owner, KJC Construction and Supply, No. 650 Divinagracia St., Lapaz, Iloilo City; the Offices of the Provincial Legal Officer, the Provincial Engineer, the Provincial Agriculturist, the Provincial Budget Officer, the Provincial Treasurer, the Provincial Accountant, the Provincial Auditor, and the Bids and Awards Committee; and the Honorable Dennis T. Valencia, Chairperson, Committee on Infrastructure, all of the Province of Iloilo, for their information and guidance;


