RESOLUTION NO. 2015-068

RESOLUTION AUTHORIZING THE GOVERNOR, HONORABLE ARTHUR D. DEFENSOR, SR., TO SIGN THE MEMORANDUM OF AGREEMENT (MOA), FOR AND IN BEHALF OF THE PROVINCE OF ILOILO, WITH THE NATIONAL IRRIGATION ADMINISTRATION WHICH DEFINES THE COOPERATION BETWEEN THE TWO GOVERNMENT AGENCIES/UNITS IN THE IMPLEMENTATION OF PROJECTS IN VARIOUS BARANGAYS WITHIN THE JALOUR RIVER MULTI-PURPOSE PROJECT STAGE II (JRMP STAGE II) PROJECT AREA IN THE PROVINCE OF ILOILO, SUBJECT TO ALL THE TERMS AND CONDITIONS STIPULATED THEREIN

"Presented for consideration under Urgent Measures is the letter dated February 6, 2015 of Governor Arthur D. Defensor, Sr., requesting for authority to sign the Memorandum of Agreement between the Iloilo Provincial Government and the National Irrigation Administration which defines the cooperation between the two government agencies/units in the implementation of projects in various barangays within the Jalaur River Multi-Purpose Project Stage II (JRMP Stage II) project area in the Province of Iloilo;

WHEREAS, the project areas of JRMP Stage II as well as the various barangays along the high line canal are located within the territorial jurisdiction of the Province of Iloilo and the beneficiaries of the dams with hydro power plant in Calinog, Iloilo will practically be the entire Province of Iloilo;

WHEREAS, the Provincial Legal Office opined that the said MOA is valid pursuant to Section 16 (*General Welfare*) in relation to Section 465 (a) and (b) (1) (vi) and (5) (*The Chief Executive: Powers, Duties, Functions, and Compensation*) of RA 7160;

WHEREAS, in view of the foregoing considerations, it is recommended that the Governor be given authority to sign the said MOA;

NOW, THEREFORE, on motion of the Honorable June S. Mondejar, Floor Leader, which was duly seconded;

RESOLVED, as it is hereby Resolved, to authorize the Governor, Honorable Arthur D. Defensor, Sr., to sign the Memorandum of Agreement, for and in behalf of the Province of Iloilo, with the *National Irrigation Administration* which defines the cooperation between the two government

agencies/units in the implementation of projects in various barangays within the Jalaur River Multi-Purpose Project Stage II (JRMP Stage II) Project area in the Province of Iloilo, subject to all the terms and conditions stipulated therein;

RESOLVED FURTHER, to furnish copies of this Resolution, the Governor Arthur D. Defensor, Sr.; Engr. Gerardo P. Corsiga, Regional Irrigation Manager, National Irrigation Administration, Brgy. Tacas, Jaro, Iloilo City; Provincial Engineer's Office; the Provincial Legal Office, all of the Province of Iloilo, for their information and guidance;
