**RESOLUTION NO. 2015-073**

**RESOLUTION AUTHORIZING THE GOVERNOR, HONORABLE ARTHUR D. DEFENSOR, SR., TO SIGN THE ADDENDUM MEMORANDUM OF AGREEMENT (MOA), FOR AND IN BEHALF OF THE PROVINCE OF ILOILO, WITH THE BUREAU OF JAIL MANAGEMENT AND PENOLOGY (BJMP) REGION VI RELATIVE TO ADDITIONAL PROVISIONS TO THE EXISTING MOA DATED JANUARY 17, 2011, SUBJECT TO ALL THE TERMS AND CONDITIONS STIPULATED THEREIN**

"Presented for consideration of the Body is Committee Report No. 7, Series of 2015, of the Committee on General Services and Human Resources, chaired by the Honorable Ninfa S. Garin, relative to the Addendum Memorandum of Agreement between the Iloilo Provincial Government and the Bureau of Jail Management and Penology, Region VI for additional provisions to the Memorandum of Agreement dated January 17, 2011;

**WHEREAS**, there is an existing Memorandum of Agreement (MOA) between the Iloilo Provincial Government and the Bureau of Jail Management and Penology (BJMP) dated January 17, 2011 on the management of then Iloilo Rehabilitation Center (IRC) and now Iloilo Provincial Integrated Jail Facility in Nanga, Pototan, Iloilo;

**WHEREAS**, under the proposed Addendum to the Memorandum of Agreement, the Province of Iloilo shall handle the repair and maintenance of vehicles used to transport inmates of the Iloilo Provincial Integrated Jail/or Iloilo District Jail, including fuel and lubricants for the 2015 budget; provide subsistence allowance of PhP 10.00 for each prisoner for 2015 budget; and provide budget for the payment of light and water including the repair and maintenance of water system for 2015 budget. The BJMP will provide a budget of PhP 50.00 per inmate for subsistence allowance in its 2015 budget and henceforth;

**WHEREAS**, however, it is not clear in the MOA if the budget for subsistence allowance of PhP 10.00 for each prisoner for the Provincial Government and PhP 50.00 for the BJMP is per day or otherwise. It was clarified with the Provincial Legal Office that the said budget amount is on a daily basis;

**WHEREAS**, further, the MOA provides that it is commonly agreed that the sole operations and maintenance of the said facility by the BJMP, subject of the MOA dated January 17, 2011, is held in abeyance on the transition period extended until December 31, 2015;



**WHEREAS**, the Provincial Legal Office opined that the proposal is valid, being in accordance with Section 465 (a) (b) (1) (vi) and (5) (*The Chief Executive: Powers, Duties, Functions, and Compensation*) in relation to Sections 16 (*General Welfare*) and 22 (a) (5) (*Corporate Powers*) of Republic Act 7160 otherwise known as the Local Government Code of 1991;

**WHEREAS**, in view of the foregoing considerations, it is recommended that the Governor be authorized to sign the Addendum Memorandum of Agreement (MOA) for additional provisions to the existing MOA dated January 17, 2011 with the Bureau of Jail Management and Penology (BJMP) Region VI. It is also suggested that the MOA should specify if the proposed budgets for subsistence allowance of PhP 10.00 for the Iloilo Provincial Government and PhP 50.00 for the BJMP are on a daily basis;

**NOW, THEREFORE**, on motion of the Honorable June S. Mondejar, Floor Leader, together with the Honorable Emmanuel R. Gallar, Vice-Chairperson, Committee on General Services and Human Resources, which was duly seconded;

**RESOLVED**, as it is hereby Resolved, to authorize the Governor, Honorable Arthur D. Defensor, Sr., to sign the Addendum Memorandum of Agreement (MOA), for and in behalf of the Province of Iloilo, with the *Bureau of Jail Management and Penology (BJMP)* Region VI relative to additional provisions to the existing MOA dated January 17, 2011, subject to all the terms and conditions stipulated therein;





