RESOLUTION AUTHORIZING THE GOVERNOR, HONORABLE ARTHUR D. DEFENSOR, SR., TO ENTER INTO CONTRACTS OF LOAN, FOR AND IN BEHALF OF THE PROVINCE OF ILOILO, WITH THE HEREINUNDER FIVE (5) COOPERATIVES RELATIVE TO THE AVAILMENT OF LOANS FROM THE PROVINCIAL LIVELIHOOD PROJECT FUND (PLPF) IN THE AMOUNT OF TWO MILLION THREE HUNDRED THOUSAND PESOS (PHP2,300,000.00): ONE MILLION PESOS (P1,000,000.00) CHARGEABLE AGAINST THE PROVINCIAL COOPERATIVE DEVELOPMENT OFFICE 2014 GENERAL FUND BUDGET UNDER THE PLPF PROGRAM, LOANS RECEIVABLES-OTHERS EXPENSE ACCOUNT AND ONE MILLION THREE HUNDRED THOUSAND PESOS (P1,300,000.00) CHARGEABLE AGAINST PROVINCIAL LIVELIHOOD PROJECT TRUST FUND BALANCE, SUBJECT TO ALL THE TERMS AND CONDITIONS STIPULATED THEREIN

WHEREAS, the Provincial Livelihood Project Fund (PLPF) is sourced out from the 20% of the IRA Development Fund of the Province. This fund is set aside to finance viable and economically feasible income generating projects. Projects included for funding are medium, small and micro-enterprises (SME), supportive of the thrust towards countryside development. This provincial livelihood project aims to support the livelihood programs of the cooperatives availing themselves of such loans at 6% interest per annum, payable for 3 to 5 years;

WHEREAS, upon assessment and evaluation of the loan applicants, the above-mentioned cooperatives have complied with the requirements in the PLPF Lending Guidelines:

WHEREAS, the Provincial Legal Office opined that the subject matter is valid pursuant to Section 22 (a) (4) and (5) (*Corporate Powers*) in relation to Section 465 (a) and (b) (1) (vi) (*The Chief Executive: Powers, Duties, Functions, and Compensations*) of the Local Government Code of 1991 (R.A. 7160) and under Section 2 of the Cooperative Code of 2008 (R.A.9520) and providing assistance to cooperatives in cash or in kind is likewise mandated under RA 9520;

WHEREAS, in view of the foregoing considerations, it is recommended that the Governor be authorized to enter into the said undertaking;


NOW, THEREFORE, on motion of the Honorable June S. Mondejar, Floor Leader, together with the Honorable Raul 'Boboy' C. Tupas, Chairperson of the Committee on Cooperatives and Other Non-Governmental Organizations, which was duly seconded;

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Governor, Honorable Arthur D. Defensor, Sr., to enter into Contracts of Loan, for and in behalf of the Province of Iloilo, with the above-mentioned five (5) cooperatives relative to the availment of loans from the Provincial Livelihood Project Fund (PLPF) in the amount of Two Million Three Hundred Thousand Pesos (PhP2,300,000.00): One Million Pesos (PhP1,000,000.00) chargeable against the Provincial Cooperative Development Office 2014 General Fund Budget under the PLPF Program, Loans Receivables-Others Expense Account and One Million Three Hundred Thousand Pesos (PhP1,300,000.00) chargeable against Provincial Livelihood Project Trust Fund Balance, subject to all the terms and conditions stipulated therein;
