RESOLUTION NO. 2015-116

RESOLUTION AUTHORIZING THE GOVERNOR, HONORABLE ARTHUR D. DEFENSOR, SR., TO SIGN THE MEMORANDUM OF AGREEMENT (MOA), FOR AND IN BEHALF OF THE PROVINCE OF ILOILO, WITH THE PHILIPPINE SPORTS COMMISSION RELATIVE TO THE IMPORTATION OF TRACK OVAL AND INSTALLATION OF LIGHTS AT THE ILOILO SPORTS COMPLEX, SUBJECT TO ALL THE CONDITIONS AND STIPULATIONS STATED THEREIN

"Presented for consideration under Urgent Measures is the letter dated March 9, 2015 of Raul N. Baniyas, M.D., MPA, OIC-Governor requesting authority for the Governor, Hon. Arthur D. Defensor, Sr. to sign the Memorandum of Agreement between the Philippine Sports Commission (PSC) and Iloilo Provincial Government for the importation of track oval and installation of lights at the Iloilo Sports Complex (ISC);

WHEREAS, by virtue of Republic Act No. 6847, the Philippine Sports Commission (PSC) is mandated to encourage wide participation of all sectors, government and private, in amateur sports promotion and development;

WHEREAS, one of the program thrusts of the PSC is to develop sports at the grassroots level in non-government organizations (NGOs), local government units (LGUs) and private entities;

WHEREAS, the Province of Iloilo is in the process of rehabilitating the rubberized track oval and installing lights for its football field at the Iloilo Sports Complex and needs the said facilities to successfully pursue its local sports program;

WHEREAS, the Province of Iloilo has requested assistance from the PSC by way of tax exemption in the importation of the materials for the rehabilitation of the rubberized track oval and installation of lights for the football field at the ISC. This is after the conduct of a public bidding in accordance with RA 9184;

WHEREAS, the PSC after due consideration, favorably considered and approved the request of the Province of Iloilo pursuant to Board Resolution No. 131-2015 dated February 12, 2015;

WHEREAS, the Provincial Legal Office opined that the said MOA is valid pursuant to the Section 16 (*General Welfare*) in relation to Section 465 (a) and (b) (1) (vi) (*The Chief Executive: Powers, Duties, Functions, and Compensation*) of the Local Government Code or RA 7160;

WHEREAS, in view of the foregoing considerations, it is recommended that Governor Arthur D. Defensor, Sr. be authorized to sign the MOA with *Philippines Sports Commission* relative to the importation of track oval and installation of lights at the Iloilo Sports Complex, subject to all the conditions and stipulations stated therein;

NOW, THEREFORE, on motion of the Honorable June S. Mondejar, Floor Leader, which was duly seconded;


RESOLVED, as it is hereby Resolved, to authorize the Governor, Honorable Arthur D. Defensor, Sr., to sign the Memorandum of Agreement (MOA), for and in behalf of the Province of Iloilo, with the *Philippines Sports Commission* relative to the importation of track oval and installation of lights at the Iloilo Sports Complex, subject to all the conditions and stipulations stated therein;


