**RESOLUTION NO. 2015-117**

**RESOLUTION AUTHORIZING THE GOVERNOR, HONORABLE ARTHUR D. DEFENSOR, SR., TO SIGN THE MEMORANDUM OF AGREEMENT (MOA), FOR AND IN BEHALF OF THE PROVINCE OF ILOILO, WITH THE MUNICIPALITY OF CONCEPCION, ILOILO RELATIVE TO THE TRANSFER OF FUNDS TO THE SAID MUNICIPALITY IN THE AMOUNT OF ONE MILLION SIX HUNDRED EIGHTY-FOUR THOUSAND EIGHT HUNDRED FORTY-TWO PESOS (Php1,684,842.00) TO FUND THE EXPENDITURE NECESSARY FOR THE ACQUISITION OF ROAD-RIGHT-OF-WAY PROVINCIAL ROAD AT BARANGAYS POBLACION, LOONG AND NIPA, SUBJECT TO ALL THE TERMS AND CONDITIONS STIPULATED THEREIN**

"Presented for consideration under Urgent Measures is the letter dated March 5, 2015 of Governor Arthur D. Defensor, Sr., requesting for authority to sign the Memorandum of Agreement (MOA) between the Iloilo Provincial Government and the Municipality of Concepcion, Iloilo for the transfer of funds to the Municipality of Concepcion in the amount of One Million Six Hundred Eighty-four Thousand Eight Hundred Forty-two Pesos (Php1,684,842.00) to fund the expenditure necessary for the acquisition of road-right-of-way Provincial Road at Barangays Poblacion, Loong and Nipa, Concepcion, Iloilo;

**WHEREAS**, the Sangguniang Panlalawigan as per Resolution No. 2014-423 appropriated an amount of One Million Six Hundred Eighty-four Thousand Eight Hundred Forty-two Pesos (Php1,684,842.00) to fund the expenditure necessary for the acquisition of road-right-of-way Provincial Road at Barangays Poblacion, Loong and Nipa, Concepcion in the Province of Iloilo;

**WHEREAS**, in view of the fact that there are a lot of claimants and it is inconvenient for them to process their claims from the Iloilo Provincial Government and likewise on the part of the Iloilo Provincial Government, to process and validate these claims, thus the Municipality of Concepcion represents these claimants instead;

**WHEREAS**, the Municipality of Concepcion is under obligation to accept the transfer of these funds and shall be responsible in the processing, validating and liquidating claims in behalf of the claimants;

**WHEREAS**, the Provincial Legal Office opined that the said MOA is valid pursuant to the Section 16 (*General Welfare*) in relation to Section 465 (a) and (b) (1) (vi) (5) (*The Chief Executive: Powers, Duties, Functions, and Compensation*) of the Local Government Code or RA 7160;

**WHEREAS**, in view of the foregoing considerations, it is recommended that Governor Arthur D. Defensor, Sr. be authorized to sign the MOA with the *Municipality of Concepcion, Iloilo* relative to the transfer of funds to the Municipality of Concepcion in the amount of One Million Six Hundred Eighty-four Thousand Eight Hundred Forty-two Pesos (Php1,684,842.00) to fund the expenditure necessary for the acquisition of road-right-of-way Provincial Road at Barangays Poblacion, Loong and Nipa, Concepcion, Iloilo, subject to all the terms and conditions stipulated therein;

**NOW, THEREFORE**, on motion of the Honorable June S. Mondejar, Floor Leader, which was duly seconded;


**RESOLVED**, as it is hereby Resolved, to authorize the Governor, Honorable Arthur D. Defensor, Sr., to sign the Memorandum of Agreement (MOA), for and in behalf of the Province of Iloilo, with the *Municipality of Concepcion, Iloilo* relative to the transfer of funds to the Municipality of Concepcion in the amount of One Million Six Hundred Eighty-four Thousand Eight Hundred Forty-two Pesos (Php1,684,842.00) to fund the expenditure necessary for the acquisition of road-right-of-way Provincial Road at Barangays Poblacion, Loong and Nipa, Concepcion, Iloilo, subject to all the terms and conditions stipulated therein;
